Other times Anita meets with a child or teen to just talk. It is amazing how they open up to her. But whatever method she uses, the kids benefit by knowing we care about them!

2006 Spotlight

Our spotlight this year is brightly shining on the "Tip Your Heart Foundation". The foundation was formed by a couple of very generous local businessmen who want to make a difference in the lives of women and children in our area. Even before they formed the foundation they were going above and beyond in their support of Lodi House.

They held a yearly golf tournament and for three years, we were the fortunate recipients of the proceeds. This amount totaled \$86,250.

This past summer, as a newly formed foundation called Tip Your Heart, they held a dinner/concert for eight hundred people at Hutchins Street Square. It was called 'Rock the Square' featuring Creedence Clearwater Revisited. Tip Your Heart underwrote the entire event and then donated all the proceeds to charities. It was a fantastic, fun event, and we were blessed to receive \$75,000 of the amount collected. This is more than we have ever received from any fundraiser or donation. We were absolutely shocked, stunned, surprised and overwhelmed. My comment upon being given the check was "Wahoooooooooo!!!"

This wonderful foundation has pulled our community together and raised \$170,250 for Lodi House. So, Tip Your Heart, thank you.... we tip our hats to you!!!
